Informal Meeting of European Council in Prague

On 7 October, the European Heads of State or Government met for an informal summit of the European Council in Prague. They discussed the war in Ukraine, energy supply as well as economic policy. On 6 October, they had already exchanged views on these topics within the newly founded European Political Community (EPC), which includes European countries that are not part of the EU: https://czech-presidency/prague-summit/informal-meeting-of-heads-of-state-or-government/

EU Parliament: TRAN Committee adopts report on Alternative Fuels Infrastructure Regulation (AFIR)

On 3 October, the TRAN Committee adopted its report on the AFIR Regulation. The rapporteur Ismail Ertug (S&D) had reached a compromise that was approved by a large majority. The report sets minimum targets for the deployment of alternative fuel infrastructure. Overall, the target goals for the electric charging infrastructure for vehicles shall be tripled. European Commission publishes consultation on Critical Raw Materials Act

On 30 September, the EU Commission published a <u>call for evidence</u> and an <u>open consultation</u> on the Critical Raw Materials Act. Critical raw materials are key to the green and digital transition as well as to other EU priorities such as Open Strategic Autonomy. To secure a sustainable supply, the European Commission has since 2008 a dedicated strategy in place and put forward an action plan in the 2020 Communication on Critical Raw Materials. Stakeholders are called to provide input in view of the changing global circumstances and related challenges for both the call for evidence and the consultation until 25 November.

Trilogue negotiations on Carbon Border Adjustement Mechanism (CBAM) ongoing

On 4 October, the second session of interinstitutional negotiations for the CBAM initiative took place in Strasbourg. The negotiators were discussing which industry sectors and type of emissions should be covered. The next session is scheduled for November. The Europe Jacques Delors think tank published a report on the acceptability of CBAM. EU Council reaches political agreement on "REPowerEU" chapters of national recovery plans

On 5 October, EU finance ministers reached a political agreement in principle ('general approach') on the legislative proposal to introduce 'REPowerEU' chapters in the national recovery plans under the Next Generation EU Recovery Plan. The legislative proposal seeks funding from the current EU budget and the European Recovery Plan to reduce Member States' dependence on Russian hydrocarbons.
